The Reserve was created as a unit of the National Park System in 1978 and is a cooperative effort of the National Park Service, State Parks, Island County and the Town of Coupeville.

The Trust Board was created pursuant to Public Law 92-463 and the Interlocal Cooperation act. Trust Board members are enrolled as Volunteers in Parks (VIPs) and perform duties as assigned by the National Parks Service. Total membership consists of nine members: three members representing Island County and one county member at large; three members representing the Town of Coupeville; one representative of State Parks & one representative of the National Parks Service. Commissioner Helen Price Johnson appointed as Commissioner representative January 5, 2009. **Four year terms.**

The Island County Affordable Housing Advisory Board was established per Interlocal Cooperative Agreement signed between the Cities of Coupeville, Langley, Oak Harbor and Island County, executed June 16, 2003.

The duties of the ICAHAB shall be to establish an application process and use and allocation recommendations regarding the disbursement of the Island County Low-Income Housing Surcharge Fund, created and authorized by way of adoption of Resolution C-48-02 on June 10, 2002.

The Advisory Board shall consist of up to 12 members appointed by the BOCC, with each of the Mayors or their designee to serve as members, along with representatives from the affordable housing construction industry, commercial real estate financing, property management companies and agencies who serve low income households.

The terms of all non-legislative representative members shall be **three years**, with initial terms staggered. (Three to serve one year, three to serve two years and three to serve three year terms). JOINT ADMINISTRATION BOARD (JAB) (Tourism)

In accordance with adoption of Ordinance No. C-154-99 on December 20, 1999 the Board of County Commissioners enacted an additional 2% special excise tax on lodging to fund a joint tourism promotion program between the Town of Coupeville, City of Langley and City of Oak Harbor, with each municipality adopting a similar ordinance. Similarly, each entity re-enacted (as a result of I-722) and confirmed in all respects the earlier action adopting the additional 2% tax.

Pursuant the **Interlocal Cooperation Act**, the participating parties also entered into a Tourism Promotion Agreement dated September 5, 2000, for joint and cooperative action to promote tourism in the County, Oak Harbor, Langley and Coupeville. These additional 2% tax funds will be used to promote tourism County-wide. Meetings are held the first Thursday of each month. By Resolution adopted October 2, 2008, the membership was increased to include the Executive Director of the Island County Economic Development Council as a member of the Board.
