- Other inspections and fees are determined by Section 108 of the current edition of the International Building Code as adopted by the State of Washington and Island County.
- The building valuation, for purposes of determining permit fees in categories not specified above or labeled ICC TABLE, is taken from the building valuation data published by the International Code Council in August of each year. Values go into effect the first of the following year. Plan review fees will be added to all applicable structures at the rate of 65% of the building permit fee.
- THERE IS A \$4.50 STATE BUILDING CODE FEE CHARGED TO ALL BUILDING PERMITS.
- A 3% technology fee increment is added to all building permits.
