PUBLIC NOTIFICATION **SEX OFFENDER RELEASE** **LEVEL 3 HIGH RISK TO THE COMMUNITY**

The Island County Sheriffs Office is releasing the following information pursuant to RCW 4.24.550 and the Washington Supreme Court decision in State v. Ward. The offender has served the sentence imposed by the Courts and is NOT WANTED by law enforcement at this time. Law Enforcement agencies do not have the legal authority to direct where an offender lives.

In 1991 an 8-year-old female relative of ADKISON'S was visiting his home during the summer. He engaged the girl in sexual behavior including the watching of pornographic videos. After his conviction here he moved to Alabama in 1995. In 2001 he was convicted in Alabama of sex crimes involving a different female relative who was 10-years-old. At this time there is no further information regarding those crimes. During the investigation of the Alabama crimes ADKISON was discovered with firearms and was subsequently convicted under federal law for a felon in possession of firearms. During this same investigation it was discovered that ADKISON had failed to register as a sex offender as required and was also convicted of that crime.

ADKISON is under Federal Probation supervision for the firearm conviction until 05.28.2011. He was released from a federal half way house on 05.24.2008 to his own home on house arrest due to medical conditions. The house arrest was concluded on 05.29.2008. ADKISON had completed 16 of 36 months sex offender treatment for his 1993 sex crime conviction when an interstate supervision transfer to Alabama was granted in 1994. ADKISON will be on supervision for his Alabama sex crime convictions until 09.22.2010 through a forthcoming interstate compact transfer with Washington Department of Corrections.

The Island County Sheriffs Office has rated ADKISON as a Level 3 Sexual Offender with high potential or risk to the public of re-offending. This assessment is based upon ADKISON'S history, records, and other assessments. ADKISON is required to complete quarterly reports in person at the Sheriff's Office. He is required to register with the Sheriff's Office in the County of his residence for life, or until relieved by the Courts of the duty to do so.
